## Types of Data collected

Among the types of Personal Data that HiLine Homes collects, by itself or through third parties, there are: first name; last name; phone number; physical address; email address; Tracker; Usage Data; unique device identifiers for advertising (Google Advertiser ID or IDFA, for example); device information; Data communicated in order to use the Service; billing address; geographic position; various types of Data; state; ZIP/Postal code; city; Data communicated while using the service; Universally unique identifier (UUID); answers to questions; clicks; keypress events; motion sensor events; mouse movements; scroll position; touch events; number of Users; session statistics; latitude (of city); longitude (of city); browser information.

Complete details on each type of Personal Data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the Data collection.

Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using HiLine Homes. Unless specified otherwise, all Data requested by HiLine Homes is mandatory and failure to provide this Data may make it impossible for HiLine Homes to provide its services. In cases where HiLine Homes specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service.

Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner.

Any use of Cookies – or of other tracking tools — by HiLine Homes or by the owners of third-party services used by HiLine Homes serves the purpose of providing the Service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy.

Users are responsible for any third-party Personal Data obtained, published or shared through HiLine Homes.

## Mode and place of processing the Data

### Methods of processing

The Owner takes appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Owner, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of HiLine Homes (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Owner at any time.

### Place

The Data is processed at the Owner's operating offices and in any other places where the parties involved in the processing are located.

Depending on the User's location, data transfers may involve transferring the User's Data to a country other than their own. To find out more about the place of processing of such transferred Data, Users can check the section containing details about the processing of Personal Data.

### Retention time

Unless specified otherwise in this document, Personal Data shall be processed and stored for as long as required by the purpose they have been collected for and may be retained for longer due to applicable legal obligation or based on the Users' consent.

## The purposes of processing

The Data concerning the User is collected to allow the Owner to provide its Service, comply with its legal obligations, respond to enforcement requests, protect its rights and interests (or those of its Users or third parties), detect any malicious or fraudulent activity, as well as the following: Contacting the User, Analytics, Advertising, Remarketing and behavioral targeting, Tag Management, Platform services and hosting, Location-based interactions, Access to third-party accounts, Heat mapping and session recording, Interaction with online survey platforms, Managing data collection and online surveys, Managing support and contact requests, Hosting and backend infrastructure, User database management, Displaying content from external platforms, Registration and authentication, Interaction with data collection platforms and other third parties, Interaction with live chat platforms, Content performance and features testing (A/B testing) and SPAM protection.

For specific information about the Personal Data used for each purpose, the User may refer to the section “Detailed information on the processing of Personal Data”.

## Facebook permissions asked by HiLine Homes

HiLine Homes may ask for some Facebook permissions allowing it to perform actions with the User's Facebook account and to retrieve information, including Personal Data, from it. This service allows HiLine Homes to connect with the User's account on the Facebook social network, provided by Facebook Inc.

### Basic information
