You will never be discriminated against, or otherwise suffer any sort of detriment, if you exercise your rights.

How to file your request

How and when we will respond to your request

We will strive to promptly respond to your requests.

In any case, should it be impossible for us to do so, we'll make sure to communicate to you the factual or legal reasons that prevent us from immediately, or otherwise ever, complying with your requests.
