#### Legal basis of processing

The Owner may process Personal Data relating to Users if one of the following applies:

- processing is necessary for compliance with a legal obligation to which the Owner is subject;

- Personal Data collected for the purposes of the Owner's legitimate interests shall be retained as long as needed to fulfill

The Owner may be allowed to retain Personal Data for a longer period whenever the User has given consent to such processing, as long as such consent is not withdrawn. - **Withdraw their consent at any time.** Users have the right to withdraw consent where they have previously given their consent to the processing of their Personal Data.

You will never be discriminated against, or otherwise suffer any sort of detriment, if you exercise your rights.

#### How to file your request

You can file your express request to exercise your rights free from any charge, at any time, by using the contact details provided in this document, or via your legal representative.

## How and when we will respond to your request

We will strive to promptly respond to your requests.

In any case, should it be impossible for us to do so, we'll make sure to communicate to you the factual or legal reasons that prevent us from immediately, or otherwise ever, complying with your requests. In cases where we are not processing your personal information, we will indicate to you the physical or legal person to whom you should address your requests, if we are in the position to do so.
