

# Cookie Policy of bluecloudventures.com and news.bluecloudventures.com

This document informs Users about the technologies that help bluecloudventures.com and news.bluecloudventures.com to achieve the purposes described below. Such technologies allow the Owner to access and store information (for example by using a Cookie) or use resources (for example by running a script) on a User's device as they interact with bluecloudventures.com and news.bluecloudventures.com.

For simplicity, all such technologies are defined as "Trackers" within this document – unless there is a reason to differentiate. For example, while Cookies can be used on both web and mobile browsers, it would be inaccurate to talk about Cookies in the context of mobile apps as they are a browser-based Tracker. For this reason, within this document, the term Cookies is only used where it is specifically meant to indicate that particular type of Tracker.

Some of the purposes for which Trackers are used may also require the User's consent, depending on the applicable law. Whenever consent is given, it can be freely withdrawn at any time following the instructions provided in this document.

Bluecloudventures.com and news.bluecloudventures.com uses Trackers managed directly by the Owner (so-called "first-party" Trackers) and Trackers that enable services provided by a third-party (so-called "third-party" Trackers). Unless otherwise specified within this document, third-party providers may access the Trackers managed by them.

The validity and expiration periods of Cookies and other similar Trackers may vary depending on the lifetime set by the Owner or the relevant provider. Some of them expire upon termination of the User's browsing session.

In addition to what's specified in the descriptions within each of the categories below, Users may find more precise and updated information regarding lifetime specification as well as any other relevant information — such as the presence of other Trackers — in the linked privacy policies of the respective third-party providers or by contacting the Owner.

## How bluecloudventures.com and news.bluecloudventures.com uses Trackers

### Necessary

Bluecloudventures.com and news.bluecloudventures.com uses so-called "technical" Cookies and other similar Trackers to carry out activities that are strictly necessary for the operation or delivery of the Service.

### Trackers managed directly by the Owner

#### sessionStorage (bluecloudventures.com and news.bluecloudventures.com)

sessionStorage allows bluecloudventures.com and news.bluecloudventures.com to store and access data right in the User's browser. Data in sessionStorage is deleted automatically when the session ends (in other words, when the browser tab is closed).

Personal Data processed: Trackers.

#### Preference Cookies (bluecloudventures.com and news.bluecloudventures.com)

Preference Cookies store the User preferences detected on bluecloudventures.com and news.bluecloudventures.com in the local domain such as, for example, their timezone and region.

Personal Data processed: Trackers.

#### localStorage (bluecloudventures.com and news.bluecloudventures.com)

localStorage allows bluecloudventures.com and news.bluecloudventures.com to store and access data right in the User's browser with no expiration date.

Personal Data processed: Trackers.

## Trackers managed by third parties

### iubenda Privacy Controls and Cookie Solution (iubenda srl)

The iubenda Privacy Controls and Cookie Solution allows the Owner to collect and store Users' preferences related to the processing of personal information, and in particular to the use of Cookies and other Trackers on bluecloudventures.com and news.bluecloudventures.com.

Google utilizes the Data collected to track and examine the use of bluecloudventures.com and news.bluecloudventures.com, to prepare reports on its activities and share them with other Google services. Google may use the Data collected to contextualize and personalize the ads of its own advertising network. In Google Analytics 4, IP addresses are used at collection time and then discarded before Data is logged in any data center or server. ## **How to manage preferences and provide or withdraw consent on bluecloudventures.com and news.bluecloudventures.com**

Whenever the use of Trackers is based on consent, users can provide or withdraw such consent by setting or updating their preferences via the relevant privacy choices panel available on bluecloudventures.com and news.bluecloudventures.com.

With regard to any third-party Trackers, Users can manage their preferences via the related opt-out link (where provided), by using the means indicated in the third party's privacy policy, or by contacting the third party.

## **How to control or delete Cookies and similar technologies via your device settings**

Users may use their own browser settings to:

- See what Cookies or other similar technologies have been set on the device;
- Block Cookies or similar technologies;
- Clear Cookies or similar technologies from the browser.

The browser settings, however, do not allow granular control of consent by category.

However, please note that Trackers help bluecloudventures.com and news.bluecloudventures.com to provide a better experience and advanced functionalities to Users (in line with the purposes outlined in this document). Therefore, if the User chooses to block the use of Trackers, the Owner may be unable to provide related features.

### **Personal Data (or Data)**

Any information that directly, indirectly, or in connection with other information — including a personal identification number — allows for the identification or identifiability of a natural person.

### **Usage Data**

Information collected automatically through [bluecloudventures.com](https://bluecloudventures.com) and [news.bluecloudventures.com](https://news.bluecloudventures.com) (or third-party services employed in [bluecloudventures.com](https://bluecloudventures.com) and [news.bluecloudventures.com](https://news.bluecloudventures.com)), which can include: the IP addresses or domain names of the computers utilized by the Users who use [bluecloudventures.com](https://bluecloudventures.com) and [news.bluecloudventures.com](https://news.bluecloudventures.com), the URI addresses (Uniform Resource Identifier), the time of the request, the method utilized to submit the request to the server, the size of the file received in response, the numerical code indicating the status of the server's answer (successful outcome, error, etc.), the country of origin, the features of the browser and the operating system utilized by the User, the various time details per visit (e.g., the time spent on each page within the Application) and the details about the path followed within the Application with special reference to the sequence of pages visited, and other parameters about the device operating system and/or the User's IT environment.

### **User**

The Data Controller, unless otherwise specified, is the Owner of [bluecloudventures.com](https://bluecloudventures.com) and [news.bluecloudventures.com](https://news.bluecloudventures.com).

### **Service**

### **European Union (or EU)**

Unless otherwise specified, all references made within this document to the European Union include all current member states to the European Union and the European Economic Area.

### **Cookie**

Cookies are Trackers consisting of small sets of data stored in the User's browser.

### **Tracker**

Tracker indicates any technology - e.g Cookies, unique identifiers, web beacons, embedded scripts, e-tags and fingerprinting - that enables the tracking of Users, for example by accessing or storing information on the User's device.
