Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using Dateability. Unless specified otherwise, all Data requested by Dateability is mandatory and failure to provide this Data may make it impossible for Dateability to provide its services. In cases where Dateability specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service. Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner.

Any use of Cookies – or of other tracking tools — by Dateability or by the owners of third-party services used by Dateability serves the purpose of providing the Service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy.

Users are responsible for any third-party Personal Data obtained, published or shared through Dateability.

Mode and place of processing the Data

Methods of processing

The Owner takes appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Owner, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of Dateability (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Owner at any time.

Place

The Data is processed at the Owner's operating offices and in any other places where the parties involved in the processing are located.

Depending on the User's location, data transfers may involve transferring the User's Data to a country other than their own. To find out more about the place of processing of such transferred Data, Users can check the section containing details about the processing of Personal Data.

Retention time

Unless specified otherwise in this document, Personal Data shall be processed and stored for as long as required by the purpose they have been collected for and may be retained for longer due to applicable legal obligation or based on the Users' consent.

How We Collect Information

Login Data: In order to provide you with access to the App, we will collect your username and password. These are needed to authenticate you when you login.

Profile Information: To complete your profile, you may add details such as photos, personal interests, and preferences, and other personal information. This information helps us facilitate matches and connect users with compatible individuals in a supportive environment.

Location Data: With your permission, we collect your device's location data to enable location-based features like showing nearby users. You can manage location permissions at any time in your device's privacy settings.

Device and Browser Information: When you use the App or Site, we may automatically collect information about your device, such as your IP address, device type, operating system, and browser type. This helps us maintain and enhance the Services' functionality and security.

Social Media IDs: We may provide you with the option to register with us using your existing social media account details such as Facebook, X (Twitter), What's App, or other social media account(s). If you choose to connect to the App this way, we will collect your social media account IDs when you provide these to us. We do this so that we can better provide you with the Services in the App.

Sensitive Information: Dateability is committed to fostering a welcoming community. You may choose to provide sensitive information, such as your health and wellness information, sexual orientation, race, ethnic origin, religious beliefs, or other identifiers that you choose to provide and to help you connect with others in our community in the App. We use this information solely to provide our Services, and by sharing it, you agree to our handling of this sensitive data.

How We Use the Information We Collect

Your information is used to create a safe and engaging experience on Dateability. Specifically, we use your information to:

Provide Core Services: Your personal information allows us to manage your profile, match you with other users, and facilitate in-app messaging, creating a space for meaningful connections.

Personalization: We use your preferences and interests to tailor match suggestions and personalize the App experience, ensuring it aligns with your values and needs.

Communication: We may use your contact information to communicate with you about updates, security alerts, and other service-related notifications. You can adjust your communication preferences in your account settings. We may use your contact information for transactional emails.

Analytics and Improvement: Data from Google Analytics and other tools help us analyze app performance and refine the Dateability experience, making it more accessible and supportive.

Marketing: We use some of the information we collect to conduct marketing activities and to deliver advertisements that may be of interest to you.

Safety and Security: Your information allows us to monitor for suspicious activity, maintain safety on the platform, and protect users from fraud and harmful behavior. We will comply with applicable law, establish, exercise and defend legal claims & rights and cooperate with law enforcement.

How We Share Your Information

We respect your privacy and do not sell or rent your information. However, we may share information in the following situations subject to contractual obligations of such third parties to protect your personal information:

Children's Privacy

Our Services are intended for users 18 and older. We do not knowingly collect information from minors. If you believe a minor has provided us with personal information, please contact us immediately, and we will take steps to delete the data.

International Data Transfers

Dateability operates in the United States, and your data may be transferred internationally. When we transfer personal data internationally, we rely on the following safeguards:

- Adequacy Decisions: We rely on adequacy decisions by regulatory bodies such as the European Commission (EC) and the UK Information Commissioner's Office (ICO), which ensure data protection standards in approved countries.
- Standard Contractual Clauses (SCCs): For transfers to third countries, we use SCCs issued by the EC or Swiss FDPIC to safeguard data in compliance with GDPR and other laws.
- International Data Transfer Agreements (IDTAs): For transfers to the U.S. and other countries, we use IDTAs approved by the ICO to ensure appropriate protection for personal data. If you have concerns about our data transfer practices, contact us for further details.

Further Information for Users in the European Union

This section applies to all Users in the European Union, according to the General Data Protection Regulation (the "GDPR"), and, for such Users, supersedes any other possibly divergent or conflicting information contained in the privacy policy. Further details regarding the categories of Data processed, the purposes of processing, the categories of recipients of the Personal Data, if any, and further information about Personal Data can be found in **the section titled "Detailed information on the processing of Personal Data" within this document.**

Legal basis of processing

The Owner may process Personal Data relating to Users if one of the following applies:

- Users have given their consent for one or more specific purposes.
- provision of Data is necessary for the performance of an agreement with the User and/or for any pre-contractual obligations thereof;
- processing is necessary for compliance with a legal obligation to which the Owner is subject;
- processing is related to a task that is carried out in the public interest or in the exercise of official authority vested in the Owner;
- processing is necessary for the purposes of the legitimate interests pursued by the Owner or by a third party.

In any case, the Owner will gladly help to clarify the specific legal basis that applies to the processing, and in particular whether the provision of Personal Data is a statutory or contractual requirement, or a requirement necessary to enter into a contract.

Further information about retention time

Unless specified otherwise in this document, Personal Data shall be processed and stored for as long as required by the purpose they have been collected for and may be retained for longer due to applicable legal obligation or based on the Users' consent.

Therefore:

- Personal Data collected for purposes related to the performance of a contract between the Owner and the User shall be retained until such contract has been fully performed.
- Personal Data collected for the purposes of the Owner's legitimate interests shall be retained as long as needed to fulfill such purposes. Users may find specific information regarding the legitimate interests pursued by the Owner within the relevant sections of this document or by contacting the Owner.

The Owner may be allowed to retain Personal Data for a longer period whenever the User has given consent to such processing, as long as such consent is not withdrawn. Furthermore, the Owner may be obliged to retain Personal Data for a longer period whenever required to fulfil a legal obligation or upon order of an authority.

Once the retention period expires, Personal Data shall be deleted. Therefore, the right of access, the right to erasure, the right to rectification and the right to data portability cannot be enforced after expiration of the retention period.

The rights of Users based on the General Data Protection Regulation (GDPR)

Users may exercise certain rights regarding their Data processed by the Owner.

In particular, Users have the right to do the following, to the extent permitted by law:

- **Withdraw their consent at any time.** Users have the right to withdraw consent where they have previously given their consent to the processing of their Personal Data.
- **Object to processing of their Data.** Users have the right to object to the processing of their Data if the processing is carried out on a legal basis other than consent.
- **Access their Data.** Users have the right to learn if Data is being processed by the Owner, obtain disclosure regarding certain aspects of the processing and obtain a copy of the Data undergoing processing.
- **Verify and seek rectification.** Users have the right to verify the accuracy of their Data and ask for it to be updated or corrected.
- **Restrict the processing of their Data.** Users have the right to restrict the processing of their Data. In this case, the Owner will not process their Data for any purpose other than storing it.
- **Have their Personal Data deleted or otherwise removed.** Users have the right to obtain the erasure of their Data from the Owner.
- **Receive their Data and have it transferred to another controller.** Users have the right to receive their Data in a structured, commonly used and machine readable format and, if technically feasible, to have it transmitted to another controller without any hindrance.
- **Lodge a complaint.** Users have the right to bring a claim before their competent data protection authority.

Users are also entitled to learn about the legal basis for Data transfers abroad including to any international organization governed by public international law or set up by two or more countries, such as the UN, and about the security measures taken by the Owner to safeguard their Data.

Details about the right to object to processing

Where Personal Data is processed for a public interest, in the exercise of an official authority vested in the Owner or for the purposes of the legitimate interests pursued by the Owner, Users may object to such processing by providing a ground related to their particular situation to justify the objection.

Users must know that, however, should their Personal Data be processed for direct marketing purposes, they can object to that processing at any time, free of charge and without providing any justification. Where the User objects to processing for direct marketing purposes, the Personal Data will no longer be processed for such purposes. To learn whether the Owner is processing Personal Data for direct marketing purposes, Users may refer to the relevant sections of this document.

How to exercise these rights

Any requests to exercise User rights can be directed to the Owner through the contact details provided in this document. Such requests are free of charge and will be answered by the Owner as early as possible and always within one month, providing Users with the information required by law. Any rectification or erasure of Personal Data or restriction of processing will be

communicated by the Owner to each recipient, if any, to whom the Personal Data has been disclosed unless this proves impossible or involves disproportionate effort. At the Users' request, the Owner will inform them about those recipients.

What are the sources of the Personal Information we collect?

We collect the above-mentioned categories of Personal Information, either directly or indirectly, from you when you use Dateability.

For example, you directly provide your Personal Information when you submit requests via any forms on Dateability. You also provide Personal Information indirectly when you navigate Dateability, as Personal Information about you is automatically observed and collected.

Finally, we may collect your Personal Information from third parties that work with us in connection with the Service or with the functioning of Dateability and features thereof.

Your privacy rights under US state laws

You may exercise certain rights regarding your Personal Information. In particular, to the extent permitted by applicable law, you have:

- **the right to access Personal Information: the right to know.** You have the right to request that we confirm whether or not we are processing your Personal Information. You also have the right to access such Personal Information;
- **the right to correct inaccurate Personal Information.** You have the right to request that we correct any inaccurate Personal Information we maintain about you;
- **the right to request the deletion of your Personal Information.** You have the right to request that we delete any of your Personal Information;
- **the right to obtain a copy of your Personal Information.** We will provide your Personal Information in a portable and usable format that allows you to transfer data easily to another entity – provided that this is technically feasible;
- **the right to opt out from the Sale of your Personal Information;** We will not discriminate against you for exercising your privacy rights.
- **the right to non-discrimination.**

Additional rights for Users residing in California

In addition to the rights listed above common to all Users in the United States, as a User residing in California, you have:

- **The right to opt out of the Sharing of your Personal Information** for cross-context behavioral advertising;
- **The right to request to limit our use or disclosure of your Sensitive Personal Information** to only that which is necessary to perform the services or provide the goods, as is reasonably expected by an average consumer. In addition to the rights listed above common to all Users in the United States, as a User residing in Virginia, Colorado, Connecticut, Texas, Oregon, Nevada, Delaware, Iowa, New Hampshire, New Jersey, Nebraska, Tennessee, Minnesota, Maryland, Indiana, Kentucky, Rhode Island and Montana you have

Legal action
