This document informs Users about the technologies that help Unispace Global Pty Ltd to achieve the purposes described below. For simplicity, all such technologies are defined as "Trackers" within this document – unless there is a reason to differentiate. For example, while Cookies can be used on both web and mobile browsers, it would be inaccurate to talk about Cookies in the context of mobile apps as they are a browser-based Tracker. For this reason, within this document, the term Cookies is only used where it is specifically meant to indicate that particular type of Tracker.

Some of the purposes for which Trackers are used may also require the User's consent. Whenever consent is given, it can be freely withdrawn at any time following the instructions provided in this document.

Unispace Global Pty Ltd uses Trackers managed directly by the Owner (so-called "first-party" Trackers) and Trackers that enable services provided by a third-party (so-called "third-party" Trackers). Unless otherwise specified within this document, third-party providers may access the Trackers managed by them.

The validity and expiration periods of Cookies and other similar Trackers may vary depending on the lifetime set by the Owner or the relevant provider. Some of them expire upon termination of the User's browsing session.

In addition to what's specified in the descriptions within each of the categories below, Users may find more precise and updated information regarding lifetime specification as well as any other relevant information — such as the presence of other Trackers — in the linked privacy policies of the respective third-party providers or by contacting the Owner.

Activities strictly necessary for the operation of Unispace Global Pty Ltd and delivery of the Service

Unispace Global Pty Ltd uses so-called "technical" Cookies and other similar Trackers to carry out activities that are strictly necessary for the operation or delivery of the Service.

Third-party Trackers

Traffic optimization and distribution

This type of service allows Unispace Global Pty Ltd to distribute their content using servers located across different countries and to optimize their performance.

The way Cloudflare is integrated means that it filters all the traffic through Unispace Global Pty Ltd, i.e., communication between Unispace Global Pty Ltd and the User's browser, while also allowing analytical data from Unispace Global Pty Ltd to be collected.

Contacting the User

The Data Controller, unless otherwise specified, is the Owner of Unispace Global Pty Ltd.

Unispace Global Pty Ltd (or this Application)

The means by which the Personal Data of the User is collected and processed.

Service

The service provided by Unispace Global Pty Ltd as described in the relative terms (if available) and on this site/application.

European Union (or EU)

Unless otherwise specified, all references made within this document to the European Union include all current member states to the European Union and the European Economic Area.

Cookie

Cookies are Trackers consisting of small sets of data stored in the User's browser.

Tracker

Tracker indicates any technology - e.g Cookies, unique identifiers, web beacons, embedded scripts, e-tags and fingerprinting that enables the tracking of Users, for example by accessing or storing information on the User's device.

Legal information
