Cookie Policy of https://xios-store.ch/

This document informs Users about the technologies that help https://xios-store.ch/ to achieve the purposes described below. Such technologies allow the Owner to access and store information (for example by using a Cookie) or use resources (for example by running a script) on a User's device as they interact with https://xios-store.ch/.

The validity and expiration periods of Cookies and other similar Trackers may vary depending on the lifetime set by the Owner or the relevant provider. Some of them expire upon termination of the User's browsing session.

Spam and bots protection
