# Cookie Policy of JOAO P.S.V.T LIVIO, ENI

This document informs Users about the technologies that help this Website to achieve the purposes described below. The validity and expiration periods of Cookies and other similar Trackers may vary depending on the lifetime set by the Owner or the relevant provider. Some of them expire upon termination of the User's browsing session.
