Types of Data collected

Among the types of Personal Data that Nixplay collects, by itself or through third parties, there are: email address; Usage Data; device information; session statistics; browser information; first name; last name; username; password; country; Trackers; billing address; shipping address; phone number; payment info; physical address; ZIP/Postal code; unique device identifiers for advertising (Google Advertiser ID or IDFA, for example); Data communicated while using the service; app information; device logs; User ID; crash data; various types of Data; Camera permission; Precise location permission (non-continuous); Social media accounts permission; Photo Library permission; Google Home permission; Universally unique identifier (UUID).

Complete details on each type of Personal Data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the Data collection.

Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using Nixplay. Unless specified otherwise, all Data requested by Nixplay is mandatory and failure to provide this Data may make it impossible for Nixplay to provide its services. In cases where Nixplay specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service.

Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner.

Any use of Cookies – or of other tracking tools — by Nixplay or by the owners of third-party services used by Nixplay serves the purpose of providing the Service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy.

Users are responsible for any third-party Personal Data obtained, published or shared through Nixplay.

Mode and place of processing the Data

Methods of processing

The Owner takes appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Owner, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of Nixplay (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Owner at any time.

Place

The Data is processed at the Owner's operating offices and in any other places where the parties involved in the processing are located.

Depending on the User's location, data transfers may involve transferring the User's Data to a country other than their own. To find out more about the place of processing of such transferred Data, Users can check the section containing details about the processing of Personal Data.

Retention time

Unless specified otherwise in this document, Personal Data shall be processed and stored for as long as required by the purpose they have been collected for and may be retained for longer due to applicable legal obligation or based on the Users' consent.

The purposes of processing

For specific information about the Personal Data used for each purpose, the User may refer to the section "Detailed information on the processing of Personal Data".

Facebook permissions asked by Nixplay

Nixplay may ask for some Facebook permissions allowing it to perform actions with the User's Facebook account and to retrieve information, including Personal Data, from it. This service allows Nixplay to connect with the User's account on the Facebook social network, provided by Facebook Inc.

Basic information

Photos

Provides access to the photos the User has uploaded, and photos the User has been tagged in.

Videos

Provides access to the videos the User has uploaded and videos the User has been tagged in.

Device permissions for Personal Data access

Depending on the User's specific device, Nixplay may request certain permissions that allow it to access the User's device Data as described below.

By default, these permissions must be granted by the User before the respective information can be accessed. Once the permission has been given, it can be revoked by the User at any time. In order to revoke these permissions, Users may refer to the device settings or contact the Owner for support at the contact details provided in the present document. The exact procedure for controlling app permissions may be dependent on the User's device and software.

Please note that the revoking of such permissions might impact the proper functioning of Nixplay.

If User grants any of the permissions listed below, the respective Personal Data may be processed (i.e accessed to, modified or removed) by Nixplay.

Camera permission

Used for accessing the camera or capturing images and video from the device.

Google Home permission

Used for accessing the Google Home and Chromecast devices and enabling Nixplay to interact with physical accessories in the User's surrounding environment.

Photo Library permission

Allows access to the User's Photo Library.

Precise location permission (non-continuous)

Used for accessing the User's precise device location. Nixplay may collect, use, and share User location Data in order to provide location-based services.

The geographic location of the User is determined in a manner that isn't continuous. This means that it is impossible for Nixplay to derive the exact position of the User on a continuous basis.

Social media accounts permission

Used for accessing the User's social media account profiles, such as Facebook and Twitter.

Meta ads conversion tracking (Meta pixel) is an analytics service provided by Meta Platforms, Inc. that connects data from the Meta Audience Network with actions performed on Nixplay. The Meta pixel tracks conversions that can be attributed to ads on Facebook, Instagram and Meta Audience Network.

Personal Data processed: Trackers; Usage Data.

Analytics

Google utilizes the Data collected to track and examine the use of Nixplay, to prepare reports on its activities and share them with other Google services. Content commenting

YouTube is a video content visualization service provided by Google LLC that allows Nixplay to incorporate content of this kind on its pages.

Hosting and backend infrastructure

This type of service has the purpose of hosting Data and files that enable Nixplay to run and be distributed as well as to provide a ready-made infrastructure to run specific features or parts of Nixplay.

Quickmail.com

Registration and authentication provided directly by Nixplay

By registering or authenticating, Users allow Nixplay to identify them and give them access to dedicated services. Direct registration (Nixplay)

localStorage

localStorage allows Nixplay to store and access data right in the User's browser with no expiration date.

Push notifications

Nixplay may send push notifications to the User to achieve the purposes outlined in this privacy policy.

Users may in most cases opt-out of receiving push notifications by visiting their device settings, such as the notification settings for mobile phones, and then change those settings for Nixplay, some or all of the apps on the particular device. Nixplay (or this Application)

The means by which the Personal Data of the User is collected and processed.

Service

The service provided by Nixplay as described in the relative terms (if available) and on this site/application.

Sale

Sale means any exchange of Personal Information by the Owner to **a third party, for monetary or other valuable consideration**, as defined by the applicable privacy US state law. Please note that the exchange of Personal Information with a

service provider pursuant to a written contract that meets the requirements set by the applicable law, does not constitute a Sale of your Personal Information.

Sharing
